## Information Notes for past students, under the age of 25 for a Foundation Governors' Award

The Foundation can grant funds to past students under the age of 25, who attended King Edward VI Community College for at least two years. Awards are to promote education, including social and physical training.

#### Criteria for awards

- Need, financial or social.
- Educational benefit
- Cannot be funded elsewhere
- Special needs/social needs Desirable
- Attempt to find other funding
- Contribution to college or community social benefit
- Demonstrated aptitude and commitment for subject

### Do not fund:

- Daily travel expenses
- Exam fees
- Equipment with a capital value: computers, cameras etc.
- Individuals who have been previously generously funded
- Travel unless it has a clear volunteering, charitable or educational benefit.
- Policy on musical instruments and tuition is under review.

### Grants to past students

- Applications must be made in advance
- Applications must be supported by a reference from a tutor, mentor, coach or employer. A person who is a relative or will benefit financially from the grant (like a private tutor) may not give the reference
- No award is given for more than 50% of costs
- Past students who have previously been substantially funded are unlikely to be given an award, unless there are exceptional circumstances
- Awards are currently in the range of £150-£400

# Who may get a grant and for what? Recent grants have been given for:

- Sports equipment and funding to allow taking part in national or international competition
- Acquiring a skill which will have benefits for others (e.g. Life saving, coaching etc.)
- Vocational projects
- Improving qualifications in order to enter or qualify for further education
- Volunteer placements abroad
- Educational opportunities for carers or students with physical or social disabilities
- Help with apprentice costs, graduate shows or Masters' applications. The latter will be in exceptional circumstances

### What the Foundation requires from an application

- The purpose is educational.
- It meets the criteria of the Foundation's policies
- It is the result of a real need, not something invented for funding.
- It will allow the student to progress.
- An indication of how matched funding will be raised.
- Value for money costings will be checked.
- A detailed reference. Remember to discuss this with your referee and give him or her time to send the reference to the college. The reference is confidential and will influence decision making. Awards will not be made without a reference.
- All the information requested is supplied.
- A commitment to use the grant help the applicant benefit others.
- Recipients to advertise how an award has helped them and are prepared to inform students.

### The application form

- Fill in each section incomplete forms will be returned or rejected.
- Apply before a course or event. Retrospective applications will not be considered.
- Answer each question clearly and briefly. You may attach typed notes.

- Show why you are in need of financial support
- Travel abroad must be insured against cancellation and proof provided.
- Remember to list previous grants, bursaries etc. This will be checked.

You will be informed of the Foundation's decision on your application and, if an award is made, given the conditions of acceptance. The awards subcommittee meets six times a year.

# **Statement Guidelines**

The Foundation's Trustees cannot accept an application without a reference from an unbiased person who knows the applicant; e.g. course tutor, employer, mentor or coach. All information will be treated in confidence.

You will enable us to identify those applicants whose educational opportunities will be transformed by a grant. Your knowledge of the applicant's circumstances, ability and attitude is invaluable. We have limited funds and must prioritize. We have a duty to consider both financial and social need. Please inform us if:

- The applicant has discussed the application with you?
- An award would meet a genuine need, not merely satisfy a want?
- It is value for money? Awards are usually between £200 and £400.
- It will allow educational progress? This can be academic, physical, creative or social.
- An award will help to combat difficulties the applicant has or is experiencing?
- The applicant shows exceptional talent which a grant would support?
- Other sources of funding might be available? The Foundation aims to match funding.

Grants are restricted to 50% of cost or less. On rare occasions, an exception has been made. Please indicate if the applicant's circumstances warrant this. Such applicants are usually from a difficult background and the awards are fairly modest.

Thank you, the Trustees are aware this will be a call on your time but we have a duty to select the most deserving for awards. We do not make retrospective awards.
