Provider Access Policy

Introduction

This policy statement sets out the college's arrangements for managing the access of providers to students at the school for the purposes of giving them information about the provider's education or training offer with regard to technical education or apprenticeships. This complies with the school's legal obligations under Section 42B of the Education Act 1997, and amended by the Technical and Further Education Act 2017.

Student entitlement

Students in years 8-13 are entitled to

• Hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships.

• Understand how to make applications for the full range of academic and technical courses.
